ENROLLMENT NEARLY TRIPLED FROM 217 FAMILIES IN 2012 TO 739 FAMILIES WITH 1,739 CHILD "SCHOLARS" AT THE END OF 2014. NAZ ENGAGES PARENTS TO COORDINATE SUPPORT FOR THEIR CHILDREN AND TO INCREASE PARENTING SKILLS AND KNOWLEDGE. FAMILIES MOVE THROUGH A "CRADLE TO CAREER" ECOSYSTEM THAT PROVIDES COMPREHENSIVE SUPPORT FROM PRE-NATAL THROUGH AGE 18, INCLUDING CUSTOMIZED PARENT EDUCATION CLASSES. RESOURCES TO HELP THEIR YOUNG SCHOLARS SUCCEED. THESE CLASSES ARE AN IMPORTANT PART OF OUR LAYERED AND ALIGNED COLLABORATIVE STRATEGY.

FAMILY ACADEMY CURRICULUM COMBINES EVIDENCE-BASED BEST PRACTICES WITH THE REAL LIFE EXPERIENCES OF NAZ FAMILIES. THE PARENTING STRATEGIES ARE PRESENTED IN WAYS THAT ARE RELEVANT TO LIVES OF NAZ FAMILIES AND THAT VALUE PARENTS' UNIQUE STRENGTHS. FAMILY ACADEMY CLASSES GIVE PARENTS THE TOOLS THEY NEED TO REACH THE GOALS LAID OUT IN THEIR ACHIEVEMENT PLANS. THE SKILLS THEY DEVELOP IN CLASS ARE REINFORCED THROUGH ONE-ON-ONE INTERACTIONS WITH THEIR NAZ CONNECTOR.

DATA SHOWS THAT PARTICIPATION IN FAMILY ACADEMY SIGNIFICANTLY IMPACTS PARENTING KNOWLEDGE AND BEHAVIORS. OUR DATA SHOWS THAT 77% OF ACTIVE PARTICIPANTS WERE PROFICIENT AT THE END OF SESSION BASED ON THE CONTENT TEST (PARENT ASSESSMENT SELF-REPORT), COMPARED TO 24% OF THE CONTROL GROUP.

KINDERGARTEN READINESS IMPROVED:

HISTORICALLY, ONLY ONE QUARTER OF CHILDREN LIVING IN OUR ZONE START KINDERGARTEN READY TO LEARN. THIS MARKS THE BEGINNING OF THE ACHIEVEMENT GAP. IN 2014, NAZ PROVIDED 109 RACE TO THE TOP SCHOLARSHIPS FOR SCHOLARS AGE 0-5 TO ATTEND THREE- AND FOUR-STAR RATED EARLY CHILDHOOD CENTERS.

- NAZ-ENROLLED 0-5 YEAR OLDS ARE SIGNIFICANTLY MORE LIKELY TO PARTICIPATE IN EARLY LEARNING CENTERS THAN NON-ENROLLED FAMILIES (42% VS. 14%).
