IN FY17, WE WORKED WITH 966 FAMILIES AND 2,105 CHILDREN, PRIMARILY IN THE ZONE. ABOUT 97 PERCENT WERE PEOPLE OF COLOR (79 PERCENT OF ENROLLED INDIVIDUALS WERE AFRICAN AMERICAN OR BLACK, 7 PERCENT HISPANIC, 5 PERCENT MULTI-RACIAL, 5 PERCENT ASIAN, AND 1 PERCENT NATIVE AMERICAN). 43 PERCENT OF NAZ ENROLLED FAMILIES IN 2016 EARNED LESS THAN \$10,000 PER YEAR, AND 73 PERCENT EARNED LESS THAN \$20,000 PER YEAR. THE VAST MAJORITY OF OUR FAMILIES ARE HEADED BY A SINGLE PARENT. AS OUR WORK HAS SCALED UP, REACHING MORE FAMILIES AND WORKING TOWARD OUR GOAL OF COMMUNITY-WIDE CHANGE, WE ARE EXPANDING OUR REACH BEYOND THE 13X18

LIKewise, 35% OF NAZ SCHOLARS PARTICIPATING IN OUT OF SCHOOL TIME ARE
